

## PETITION TO ESTABLISH PARENTAL RELATIONSHIP - *Instructions*

Paternity, parentage or “establishing paternity” is a legal means of determining who is or, in some cases, who is NOT the parent of a child. See Family Code §7630 et seq.

***If a person is established as a legal parent of a child, that person must support the child financially! If a legal parent does not financially support a child, he/she may be subject to civil and/or criminal penalties.***

- #2. **FILING FEE or FEE WAIVER:** There is a FEE for filing the papers. If you cannot afford the filing fee, ask for a Fee Waiver packet, complete it and file it.
- #3. **MAKE COPIES:** Make sufficient number of copies - original + 2 copies.
- Attach a **blank** Response to Petition to Establish Parental Relationship (Uniform Parentage) plus a **blank** UCCJEA Declaration and **blank** Income and Expense or **blank** Financial Statement (Simplified) to **RESPONDENT’S SET OF PAPERS.**
- #4. **FILE THE PETITION & SUMMONS:** Take the original and copies and the filing fee or fee waiver to the Family Law Division and file them. **Your case is confidential.** You will **need valid picture identification** to pick up your copies and view the file. The other party will also **need** valid picture identification to view the file. See Fam. Code §7643.
- #5. **SERVE RESPONDENT:** Have a 3<sup>rd</sup> person (**SERVER**), 18 years or older and not a party or witness to the case personally deliver the documents to the Respondent. The **server** completes the Proof of Service of Summons, form FL-115.

**#6. FILE THE PROOF OF SERVICE** with the Family Law Clerk ASAP. Make note of the date the Respondent was served:

**#8.** The Clerk of the Court will send out *Notice of Mandatory Settlement & Trial Setting*

**#11.** Go to Trial

**#12.** Prepare Judgment, Notice of Entry of Judgment, Envelopes, and Postage Stamps

**STANDARD RESTRAINING ORDER**  
(Parentage—Custody and Support)

**ORDEN DE RESTRICCIÓN ESTÁNDAR**  
(Paternidad—Custodia y Manutención)

**Starting immediately, you and every other party are restrained from removing from the state, or applying for a passport for, the minor child or children for whom this action seeks to establish a parent-child relationship or a custody order without the prior written consent of every other party or an order of the court.**

This restraining order takes effect against the petitioner when he or she files the petition and against the respondent when he or she is personally served with the *Summons* and *Petition* OR when he or she waives and accepts service.

This restraining order remains in effect until the judgment is entered, the petition is dismissed, or the court makes other orders.

This order is enforceable anywhere in California by any law enforcement officer who has received or seen a copy of it.
