**WHAT IS PATERNITY?** Paternity, parentage or “Establishing Paternity” means saying who is (or in some cases) who is NOT the legal parents of a child. You can file this Petition when:

- The parents were not married at the time the child was born;
- The parents did not get married after the child was born;
- The parents did not sign a Voluntary Declaration of Paternity “POP Declaration”,
- The Local Child Support Agency did not establish a case against either/both parents.

***WARNING! If a person is established as a legal parent of a child, that person MUST support the child financially! If a legal parent does not financially support a child, he/she may be subject to civil and/or criminal penalties.***

***NOTE: Only the following courts in Kern County accept Petitions for Paternity: Metropolitan Division-Justice Building; East Division – Ridgecrest Branch; East Division – Mojave Branch.***

**#4 FILE THE PETITION & SUMMONS: Take the forms and filing fee or fee waiver to the Family Law Division so the Clerk can assign you a case number and stamp your papers.**

**#5 SERVE RESPONDENT: Have a 3<sup>rd</sup> person (**SERVER**), 18 years or older and not a party or witness to the case personally serve the documents to the Respondent. **Server** completes the Proof of Service of Summons (FL-115).**

**#6 FILE THE PROOF OF SERVICE with the Family Law Clerk ASAP. Make note of the date the Respondent was served:**

**STANDARD RESTRAINING ORDER**

**You and the other party are restrained from removing from the state the minor child or children for whom this action seeks to establish a parent-child relationship without the prior written consent of the other party or an order of the court.**

This restraining order is effective against petitioner upon filing a petition and against respondent on personal service of the summons and petition or on waiver and acceptance of service by respondent.

This restraining order is effective until the judgment is entered, the petition is dismissed, or the court makes a further order.

This order is enforceable anywhere in California by any law enforcement officer who has received or seen a copy of it.
