

Compensation

Grand Jurors make a commitment to serve a minimum of 20 hours per week (a minimum of five hours a day, four days a week) for a one-year term. They receive a stipend based on the number of days severed. Grand Jurors are also reimbursed for personal vehicle usage at the prevailing County mileage rate.

Complaints and Investigations

Any individual may submit a complaint to the Grand Jury. Complaints should include specific information, allegations, and documentation. All complaints are formally acknowledged and remain confidential. Upon conclusion of an investigation, the complainant will receive a letter to communicate the complaint has been closed.

The Grand Jury also investigates:

- Charges of malfeasance (wrongdoing)
- Misfeasance (a lawful act in an unlawful matter)
- Nonfeasance (failure by public officials to perform a required act)

The Final Report

At the end of each term, the Grand Jury submits a Final Report to the Presiding Judge. This document consolidates the investigative reports prepared and pre-released throughout the year by the Grand Jury, including findings and recommendations. The Final Report is available to the public and media online at:

Elected officials are required by law to respond to findings and recommendations contained in the Final Reports within 60 days of release. Other county entities must respond within 90 days.

Confidentiality

The Grand Jury is sworn to secrecy and complete confidentiality as it pertains to complaints, witnesses, or content of investigative matters. This ensures the protection and privacy of anyone coming before the Grand Jury with, or in response to, a complaint. No confidential information leaves the Grand Jury chambers.

Why Become a Grand Juror?

Each year nineteen volunteer citizens are impaneled from the community to serve as the Kern County Grand Jury.

The Grand Jury is an investigatory "watchdog" body created to ensure that the best interests of all the citizens of Kern County are being served by local government. The volunteers enter this service to learn more about the administration and operation and to ensure these bodies of government comply with fiduciary responsibilities and are governed effectively.

Kern County Grand Jury

What You Should Know

The Kern County Grand Jury is a body of 19 citizens who are independent of any political or special interest group. No specific credential is necessary to be a Grand Jury member though an avid interest in all governmental agencies within Kern County is essential. The Grand Jury is a diverse group of men and women with a wide range of backgrounds, experience, and interests, covering a broad spectrum of beliefs.

What the Grand Jury Does

- Will objectively investigate, audit, or examine all aspects of County government, special districts, and cities to ensure that these bodies are being effectively governed and that public monies are being handled prudently and in the best interests of the public.
- May subpoena persons and/or records to obtain information on subjects under investigation.
- May conduct criminal hearings to hand down criminal indictments.

Eligibility Requirements

You are eligible to be a grand juror if you:

- Are a citizen of the United States and at least 18 years or older.
- Have resided in the County of Kern for the past year.
- Have sufficient knowledge of the English language.
- Have not been discharged as a grand juror in any other county in California within one year.
- Have not been convicted of malfeasance in office or any felony or high crime.
- Are not serving as an elected public officer.

Selection Timeframes and Process

- Each year, the Superior Court solicits applications for volunteers to serve on the Grand Jury.
- Applicants must attend a Mandatory Information Overview Meeting in March.
- All applications undergo a screening process, followed by a background check.
- A committee of Superior Court Judges interviews each qualified applicant and nominates prospective jurors.

- In the spring of each year, the Clerk of the Court conducts the first random drawing to reduce the list of prospective jurors to 30 individuals.
- The Presiding Judge may hold over as many as ten jurors from the previous Grand Jury.
- In June, the final random drawing is held to select the 19 grand jurors and alternates.
- Grand jurors are impaneled to serve a one-year term from July 1 through June 30.

Grand Jury Officers and Committees

The Presiding Judge of the Superior Court appoints a foreperson for the Grand Jury. The foreperson selects a foreperson pro-tem, recording secretary, a sergeant-at-arms, and an assistant sergeant-at-arms.

Each juror may be assigned to one or more committees, including:

- Administration, Audit and County Services
- Cities and Joint Powers
- Health, Education, and Social Services
- Law and Justice
- Special Districts
