#### **HOW TO RESPOND**

- 1. COMPLETE THE FORMS. (Type or print, blue or black ink only. Writing must be legible)
  - Response to Petition for Custody and Support of Minor Children (FL-220)
  - Child Custody and visitation Application Attachment (FL-311)
  - Declaration Under UCCJEA (FL-105)
- 2. DATE, PRINT NAME AND SIGN ALL FORMS BEFORE FILING.
- 3. MAKE COPIES OF EACH FORM. Make two (2) copies of each form, front and back pages.
- 4. <u>SERVE YOUR DOCUMENTS.</u> Have a copy of the Response "served" on the other party by mail or personal service. To "SERVE" means that someone other than you, over the age of 18, and not a party to this action delivered (served) one of the copies of the papers to the other party. The Response must be served on the other party and filed with the Court no later than 30 days from the date you were served with the Summons and Petition.
- 5. COMPLETE PROOF OF SERVICE. Once service is complete, the person who served the papers must complete and sign the PROOF OF SERVICE BY MAIL (Form FL-335) included in this packet. This form must be attached to your Response when filing. \*If service was in person, the server must complete and sign the PROOF OF PERSONAL SERVICE (Form FL-330) -forms available on-line at www.courts.ca.gov/forms.
- 6. <u>FILE WITH COURT</u>. File the original form and copy with the Family Law Department. The clerk will keep the original and return the filed stamped copy for your records.
- 7. <u>FILING FEE.</u> There is a filing fee of \$435.00. If you cannot afford the filing fee, you may be eligible to have the fee "waived" by completing an <u>Application for Fee Waiver</u>— ask the clerk for a packet.
- 8. <u>FOLLOW-UP</u>. **These forms only respond to the action**. \*Note: In order to obtain an enforceable order or a Judgment (Final Order) additional forms are required ask the clerk for further packets.
