

PROFESSIONAL SUPERVISED VISITATION PROVIDERS

According to Family Code Section 3200, all providers of supervised visitation **must** operate their programs in compliance with the “Uniforms Standards of Practice for Providers of Supervised Visitation” which can be found in the California Rules of Court, Standards of Judicial Administration, [Standard 5.20](#).

Therefore, when selecting one of the following professional supervised visitation providers it is very important that you, as parents, be familiar with the Standards of Practice and use good judgement when selecting any provider.

The Court has required each provider on the referral list to register with TrustLine or cleared through a criminal background check. TrustLine requires all caregivers listed on its registry to pass a background screening that qualifies them to be a childcare provider. All persons listed on TrustLine have been cleared through a fingerprint check of records at the California Department of Justice and have no disqualifying criminal convictions or substantiated child abuse reports in California that would prevent them from being a childcare provider. As a provider may be spending some time alone with your child, it is wise to select a provider that is registered. It is your responsibility as a parent, to verify that the provider is actually registered by calling 1-800-822-8490.

Providers on this list are required to provide proof of the 24 hour of training with the Judicial Council of California in specified topics per [3200.5 \(d\) \(1\)](#).

PLEASE NOTE:

- Individuals on this list have **signed an Annual Declaration for 2026** stating they will provide supervised visitation according to the “*Uniform Standards of Practice for Providers of Supervised Visitation*.” Any other services the programs provide, other than supervised visitation or supervised exchange is not covered in this declaration.
- Although it is required that these programs be in compliance with the “Standards of Practice,” there is no governing body that oversees these programs.
- Each service provider is a separate entity with its own governing board and/or operating policies and procedures.
- **Kern County Superior Court does not monitor, evaluate, or endorse the quality of these providers. See the disclaimer below.**
- **The Court can address changes to the Professional Supervised Visitation Providers, visitation times, and complaints through notice**
